 derwood his wife of Columbia, State  
 of Texas County aforesaid, by this deed of gift, do  
 transfer, give, grant and convey to our beloved son  
 Joseph Patterson Underwood the tract of land in  
 said town, County and State aforesaid, described as follows.

To wit: Commencing On Hundred and Six feet from the outer
