D. M. Underhill, Washington Co. F. L. Randle, Lydelton Smith, and W. H. Vinson affirmed identity, 1878. W. M. Anderson witnessed p/a Jan 1884. He was still living in Washington Co. Mar 1884.

✓ Ammon Underwood, Columbia, Brazoria Co., 19 Dec 1870, suspended. Age 60. He was a soldier in the army of Texas from Sep 1835 until summer of 1836. He was in John W. Hall's company and served as a military store keeper at Columbia. Thomas H. Borden and William T. Austin, Galveston Co., affirmed service.

Estevan (X) Uron, Bexar Co., Jan 1875, approved. Age 60. In Dec 1835 at Goliad he joined Capt. Phillip Dimett's company and served in the siege of San Antonio.

Y. Leal, Bexar Co., affirmed that an affidavit by Diego Gonzales which stated that Uron was in the company of Capt. Leal was in error. Pablo Salinas and Juan Seguin, Bexar Co., affirmed service.

Uron was born in Goliad in 1814. In a letter from attorney to Comptroller he said that Querino Garza was blind and this was not stated in his application. He also mentioned the pension applications of the following: Guerrero, Almanse, and Diego Gonzales.

Francisco (X) Valdez, San Antonio, Bexar Co., Sep 1874, approved. Age 64. In Oct 1835 until Dec 1835 he served as a cook in J. N. Seguin's company. Manuel Flores was 1st lt. of the company. He was at the grassfight and bore arms along with his comrade Antonio Sanchez and also at Molino Blanco. He received a bounty warrant for his service.

Rita Guerra de Carrancio, Bexar Co., 57 years old, was born and raised in Bexar Co. and had known the applicant as long as she can remember. She remembered a conversation with her father concerning land for service. Cosmo (X) Flores and Juan (X) Rodríguez, Bexar Co., affirmed identity Apr 1887. Jesus Gomez affirmed identity. Juan Rodriguez, Bexar Co., born 1819, knew that the applicant was with the troops at Molino Blanco. Antonio Sanchez had known that applicant since 1830 and affirmed service. Francisco Casanova, Bexar Co., born in 1830, had known applicant as long as he can remember.

Valdez was born in San Antonio. His father was Jose Ma. Valdez, but he died when that applicant was young. His oldest child was about 25.

F. Valdez (in the folder of Francisco Valdez). Jose Alameda, Bexar Co., born in 1812, served in the same company with Valdez and was with him at the battle of Concepcion and Molino Blanco. He had not seen him in 50 years.
